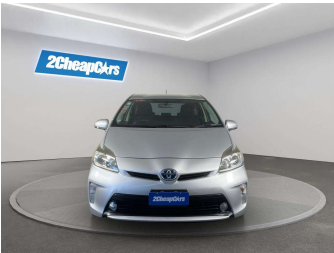

The interest rate used in this calculation is an arbitrary 14.95%, however exact interest rates vary per lender. The term of the loan used in this calculation is 60 month. Exact terms available vary per lender although options typically include 6, 12, 18, 24, 36, 48 and 60 months. This calculation also includes two typical mandatory fees charged by lenders. These are an account admin fee of \$1.80 per month (other payment frequencies may be available) and a one-off establishment fee of \$495.00. Typically, this fee can be paid upfront or, as in this calculation, be capitalised over the contract term, ie. included in the loan amount. These fees can vary per lender and other non-mandatory fees and charges may also apply. The total amount of repayments has been calculated by multiplying 260 weekly repayments (based on a 60 month term) by the weekly repayment amount of \$5.84 which equals \$1,728.92.
